If you choose to draw your own plans, plans must contain all necessary information required on the ACC request form. Dimensions of the project, location of project relative to main structure, building lines, and materials to be used.

Self-drawn plans must be legible and lines and dimensions must be accurate. If you need assistance in drawing your plans, we have a list of local college students that can assist you for a small fee.

- a BEFORE picture of the home and/or the area of the proposed changes,
- submit material color samples,
- and/or drawings, if required (as stated in #3.)
