2023 ANNUAL ASSESSMENTS INCREASE TO \$300 PER LOT

Annual assessment invoices were sent out on November 26, 2022. They are due in the WCA office by January 31, 2023. In accordance with the declarations and covenants of the subdivision, the obligation as stated is to pay per lot. The 2023 assessment rate has increased from \$250 to \$300 per lot. The dues have not increased in twelve (12) years. Due to inflation over the past twelve (12) years the Board has voted to increase the dues. Trash, street lights, security, landscaping, and insurance have all increased throughout the twelve (12) years, and the association has worked tirelessly to keep the dues \$250 for as long as possible.

The assessment payment is mandatory and is legally enforceable as a condition of living in a deed-restricted community. Homeowners are encouraged to pay their assessments promptly to avoid late charges. Late payments received on or after February 1, 2023 will be assessed a \$25.00 late fee. Payments received on or after March 1, 2023 will be assessed an additional \$45.00 late fee. There is a \$25.00 fee for trash disconnection and an additional \$25.00 for trash service reconnection. The 2023 assessments can be paid in the WCA office by check, money order, or credit card (\$5.00 service fee when using a credit or debit card). We also accept payments 24 hours a day/7 days a week through our drop box located at 314 Freeport Street. Failure to pay by April 15, 2023, may result in disruption of trash service and possible legal action (at the discretion of the WCA).

REMOVAL OF TRASH CANS

It is your responsibility to store your trash cans properly. That means the driveway or side yard is only an acceptable location on your specific trash pickup days. At all other times trash cans need to be out of sight and secure. Poor trash retention has also uncovered a growing problem with local varmints foraging for food. Non-compliance with "trash can etiquette" may get you a violation letter and/or a fine if request(s) are ignored.

Security in Woodforest

Over the past few months, we've been getting calls about various safety issues throughout the neighborhood. It's important to understand that the HOA Board is not a policing force. We are your neighbors simply volunteering our time to help the community. We can't help with your neighbors acting out, or if your car got broken into. However, we have recently contracted a second officer to patrol the neighborhood. We now have two officers patrolling the neighborhood for a total of 40 hours per week. As always, any criminal activities should still be directed to the Harris County Sheriffs Department. However, we DO encourage you to email or call the office so that we can keep track of any issues within our community, and relay all information to our community officers. PARKING OF VEHICLES

(In accordance with Amended Rules & Regulations – Section 3.04 (2) (a-b)

Street congestion is an ongoing issue on numerous streets. Street parking is one of the easiest rules to abide by; yet it seems to be a consistent problem that is reported daily. This is just one requirement of living within a deed restricted community. Applicable deed restrictions are paraphrased below:

*Parking of vehicles on the grass or lawn is strictly prohibited.

*Parking of ALL vehicles are limited to driveways and garages only.

*No vehicle shall EVER be parked as to block other neighbors from accessing their driveways.

*No vehicle shall park on the street for a period longer than twelve hours.

Community Safety

Because we live within a community association, the potential to solve the kinds of problems that plague individual homeowners is very good. Take community safety for instance. An individual homeowner can help deter a burglary by installing an alarm which will notify the authorities after any criminal activity has been committed. We are fortunate in Woodforest to have Harris County Sheriffs office and Precinct 3 Constables patrol, but they need your assistance. Please report any and all crime to the Sheriff's department or Precinct 3 Constables. You can report crime anonymously with the Constables by calling (832) 927-8477. As a resident of Woodforest, we can keep our community safe and help eliminate vandalism, burglary and other community based crime with participation by all of the members of our community. If we all kept an eye out on our neighbors' houses while they are away, reported suspicious activity and/or persons, and complied with our rules and regulations, then we could help deter the cause of neighborhood crime. Lets start focusing on the positives and work together to contribute to community safety.
